# **Centre Staff Requirements:**

### **Internal Quality Assurers, Tutors and Assessors** must:

- 1. Be **registered** and recognised by an Approved Centre, registered and approved by MP Awards.
- 2. Hold, or are working towards the appropriate qualification, as specified in the **Assessment Principles for First Aid Qualifications**.

### **Trainers**

Those involved in the training of these qualifications must have knowledge and competency in First Aid as well as knowledge and competency to train based on qualifications and experience. An acceptable portfolio must show:

- i. Occupational knowledge and competence in first aid evidenced by:
  - Holding a First Aid at work/medical qualification as detailed in Appendix 1
- ii. Knowledge and competency in teaching/training first aid evidenced by:
  - Holding an acceptable teaching/training qualification as detailed in Appendix 2

#### AND either:

- Providing an acceptable log of teaching First Aid within the last 3 years or
- Providing an acceptable record of competently teaching theoretical and practical first aid sessions under the supervision of a suitably qualified Trainer/Assessor

#### Assessors

Those involved in the assessment of these qualifications must have knowledge and competency in First Aid, as well as knowledge and competency to assess based on qualifications and experience. An acceptable portfolio must show:

- i. Occupational knowledge and competence in first aid evidenced by:
  - Holding a First Aid at work/medical qualification as detailed in Appendix 1
- ii. Knowledge and competency in assessing first aid evidenced by:
  - Holding an acceptable assessing qualification/CPD Training as detailed in Appendix 2

### AND either:

- Providing an acceptable log of First Aid assessments conducted within the last 3 years or
- Providing an acceptable record of competently assessing theoretical and practical First Aid qualifications under the supervision of a suitably qualified assessor.

## **Internal Quality Assurance**

Those involved in the Internal Quality Assurance of these qualifications (IQAs) must have knowledge and competency in First Aid as well as knowledge and competency in Internal Quality Assurance. An acceptable portfolio must show:

- i. Occupational knowledge and competence in first aid evidenced by:
- Holding a First Aid at work qualification/medical registration as detailed in Appendix 1
- ii. Knowledge and competency in internal quality assurance evidenced by:
  - Holding an acceptable internal quality assurance qualification/completing CPD training as detailed in Appendix 3

# Internal Quality Assurers must:

- Have knowledge of the requirements of the qualification they are quality assuring at the time any assessment is taking place.
- Have knowledge and understanding of the role of assessors.
- Visit and observe assessments.
- Carry out other related internal quality assurance.

# Appendix 1

## **Occupational Knowledge and Competence in First Aid**

All Trainers, Assessors, Internal Quality Assurers and External Quality Assurers must have occupational knowledge and competence in First Aid.

## This may be evidenced by:

• Holding a qualification issued by an Ofqual/SQA/Qualifications Wales/CCEA Regulation recognised Awarding Organisation/Body (or equivalent <sup>1</sup>) as follows:

Qualification delivered:	Minimum qualification to be held by the Trainer/Assessor/IQA/EQA: 1
First Aid at Work or Emergency First Aid at Work	First Aid at Work
Paediatric First Aid or Emergency Paediatric First Aid	Paediatric First Aid or First Aid at Work

- Current registration as a Doctor with the General Medical Council (GMC<sup>2</sup>); Or
- Current registration as a Nurse with the Nursing and Midwifery Council (NMC<sup>2</sup>); **Or**
- Current registration as a Paramedic with the Health and Care Professions Council (HCPC<sup>2</sup>).

<sup>&</sup>lt;sup>1</sup> if the trainer/assessor/IQA/EQA holds a non-regulated first aid qualification the awarding organisation should undertake due diligence to ensure current occupational knowledge and competence.

<sup>&</sup>lt;sup>2</sup> registered healthcare professionals must act within their scope of practice and therefore have current expertise in first aid to teach/assess the subject.

### NOTE:

IQAs who do not hold a formal IQA qualification may alternatively attend Internal Quality Assurance CPD Training with an Awarding Organisation/Body.

### Certificates

The date of certification should be based on the **achievement of the final unit**. The validity period of the qualification, as specified in **Table 2**, should be calculated from that date.

Certificates issued for Emergency First Aid at Work or First Aid at Work Qualifications must contain the following:

- Reference to the Health and Safety (First-Aid) Regulations 1981;
- Confirmation that the certificate is valid for three years from the date of achievement of the final unit;
- The name of the training organisation (where permissible by the qualification regulator)

### **Duration of Training**

The minimum duration of contact hours (time set aside for direct teaching and assessing excluding breaks) for each qualification is set out in **Table 2**.

For FAW/EFAW the total contact hours should be for a minimum of:

- First Aid at Work 18 hours over three days.
- First Aid at Work Re-qualifying\* 12 hours over two days.
- Emergency First Aid at Work 6 hours over one day.

# \*FAW Re-qualifying

Candidates who have previously attained the FAW qualification should re-qualify by undertaking the full qualification again. Providing the Learner's FAW certificate has not expired by more than 28 days, the contact hours may be reduced to 12 hours over 2 days. Candidates must be assessed against all learning outcomes and assessment criteria in the units. To attend the shorter re-qualification course, Candidates should provide evidence of their previous FAW qualification.

AOs, Centres and employers should be aware that if a workplace first aider's certificate expires, they will not be accepted as a first aider for the purposes of the First Aid at Work Regulations until they have re-taken the qualification.

# **Lesson plans**

Centres should plan and deliver training in accordance with detailed lesson plans, detailing timetables for delivery, aims, outcomes and objectives for each session, Candidate and trainer activity. Training should be delivered to the principles set out in NOS 7 Facilitate Individual Learning and Development.

## **End of Course Evaluation**

Centres should have an evaluation procedure, based on Candidate feedback, to evaluate the ability of the Trainer/Assessor, the structure and content of the course, the equipment used and the training venue.

## **Internal Quality Assurance**

In addition to monitoring assessments, IQA monitoring undertaken by centres should **also** verify the Trainer's ability in **teaching** First Aid.

- 1. Time set aside for direct classroom teaching and assessing excluding breaks.
- 2. Minimum number of days over which the training should be delivered.
- 3. Maximum number of weeks over which the qualification can be attained. Special considerations may be taken into account to increase this duration if necessary.
- 4. Minimum duration of any one training session.
- 5. Maximum number of Learners per trainer or Learners per assessor at any one time.
- 6. Validity period of certificate to be calculated from the date of achievement of the final unit.
- 7. Indicated if annual refreshers are recommended for the qualification in the years between re-qualifying. It is accepted that not all IT systems will allow, but if possible, AOs should indicate that annual refreshers are recommended on certificates, ideally indicating the month/years in which the annual refreshers should take place, along with the date before which full re-qualification should be undertaken.

### **Assessment Methods:**

Must be assessed and quality assured in accordance with the First Aid Assessment Strategy and MP Awards evidence requirements.

Skills and knowledge must be taught and assessed in accordance with currently accepted First Aid practice in the United Kingdom. At present, HSE accepts the First Aid management of injuries and illness, in as far as they relate to the topics covered in an EFAW and FAW training course, as laid down:

- By the Resuscitation Council (UK); and
- In other publications; provided that they are supported by a responsible body of medical opinion.

For this qualification all learning outcomes must be assessed using methods appropriate to the assessment of competence-based qualifications. There must be valid, authentic and sufficient evidence for all the assessment criteria. The primary source of evidence will be from by observation of practical demonstration in the training environment, course participation and questioning/discussions.

Simulation is permitted for this qualification.

## **Minimum Evidence Requirements:**

Competence must be demonstrated by achievement of all assessment criteria.

## **Assessment System:**

Whilst Approved Centres are free to develop their own assessment record system; MP Awards has developed a ready-made system for Centres to use which is available at no cost. However, Centres are advised to check with MP Awards when devising their own assessment system to ensure it meets the standards in full.
